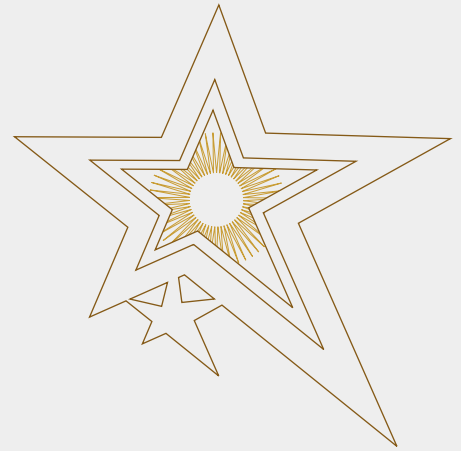

Leadership	• Demonstrate how you embody a set of values and a code of ethics, serving as a role model for your organization or team. • Describe how you actively review management systems and performance to ensure continuous improvement. • Highlight the number and significance of successfully completed healthcare projects where you have acted as a Project Leader. • Share instances where you have overcome challenges and obstacles to achieve remarkable accomplishments.
Qualification & Experience	• Submit your professional degrees (BSc., Master, MBA, PhD, etc.). • Detail the significant number of years of leadership experience you possess within a medical/pharmaceutical facility. • Submit relevant qualifications, including local, regional, or global certifications. • Highlight any distinctions, ranks, or high marks achieved in medical or other qualifications. • Describe your medical experience (IPD/OPD) within UAE/Outside UAE.
Competence, Learning & Development	• Illustrate the various medical/other competencies you have acquired and demonstrate their utilization in the last 3 years. • Provide examples of training programs you have conducted as a Trainer in the last 3 years. • Showcase your commitment to continuous learning by attending training programs regularly, accumulating a substantial number of hours in the last 3 years. • List certifications from medical training attended in the last 3 years.
Productivity & Performance	• If applicable, mention any JCI accredited healthcare facilities run by you. • Demonstrate the presence of a favorable trend in safety-related occurrences/incidents at facilities. • Describe the improvements in patient care/surgeries errors achieved in the last 3 years. • Illustrate the impact of your projects on the overall healthcare sector of Dubai Emirate. • Mention the number of healthcare facilities/projects you run.

Innovative Contributions	• Detail innovative initiatives implemented in the last 3 years, such as new products, services, technology, patient care, system/processes/procedures, safety practices, patient satisfaction, customer service improvements, and cost/sustainability improvements. • Kindly showcase any patents, published research, and noteworthy literature/write-ups associated with your name as evidence of your accomplishments and contributions
Internal & External Awards / Appreciations	• List any local, regional, and international awards received on an individual level. • Include any local, regional, and international awards received on a corporate level. • Share testimonials from local/overseas patients/customers. • Highlight instances where you received invitations as a Conference Chair for local/regional/global conferences and acted as a speaker in significant conferences.
Corporate Social Responsibility	• Illustrate your involvement in Corporate Social Responsibility (CSR) or Volunteer Projects as a leader. • Highlight any CSR/Volunteer Projects where you are a member.
Customer Experience	• Highlight improvements in patient/customer comfort in the last 3 years. • Demonstrate your efficiency in managing patient/customer complaints, encompassing timely acknowledgment, prompt resolution, and implementation of corrective, preventive, and improvement measures. • Provide formal appreciations received from international organizations.
Best Healthcare Influencer	This special category honors individuals who use the power of social media to inspire, educate, and create awareness about health and wellness. From sharing expert medical advice to promoting healthy lifestyles, these influencers make a positive impact by connecting with audiences, spreading accurate health information, and encouraging better choices. This award celebrates their creativity, credibility, and contribution to public health awareness in the digital space.

HOW TO APPLY

Individuals/organizations are encouraged to indicate their interest in participating by submitting the online registration as early as possible. The registered applicants will then be considered for nominations by the Health Awards Team. Nominated candidates will receive an application form that must be completed and submitted as soon as possible. The Awards body reserves the right to decline any application that does not meet the criteria set for the said Award Category

ASSESSMENT

The process for HEALTH awards follows a transparent assessment procedure.

Nominees undergo rigorous scrutiny of their claims and credentials, ensuring that only the most deserving ones are included in the final list.

The nominations for HEALTH Awards 2025 will be evaluated by 15 external evaluators, including site visits, and ultimately judged by an eminent jury.
